\_\_\_\_\_ I am not under the influence of drugs or alcohol. To my knowledge, I do not have any physical, mental, or medical impairment or disability which might affect my well-being as a direct or indirect result of my decision to have a piercing done at this time.

\_\_\_\_\_ I acknowledge that obtaining a piercing is my choice alone and will result in a permanent change to my appearance, and that the skin involved in the piercing will not be restored to pre-piercing condition. I understand that even with optimal aftercare the piercing may incur complications and/or have to be removed. If I choose to seek piercing advice from a physician, the Piercer is not responsible for expenses acquired.

\_\_\_\_\_ I understand I will be pierced using sterile instruments and jewelry, using aseptic technique compliant with Florida Statute 381.0075 & Rule Chapter 64E-19. The jewelry used for all initial piercings is **medical implant quality (where applicable), or is comprised of an inert and biocompatible material.**

\_\_\_\_\_ I understand my Piercer provides free lifetime aftercare advice, but it is MY responsibility to monitor the piercing **daily** and bring any issues or concerns to the attention of my Piercer **immediately.**
